### **FIRST AID**

### Carbaryl is an N-Methyl Carbamate Insecticide.

Contact a physician immediately in all cases of suspected poisoning. Transport patient to a physician or hospital immediately and SHOW A COPY OF THIS LABEL TO THE PHYSICIAN. If poisoning is suspected in animals, contact a veterinarian.

This product is a pyrethroid. If large amounts have been ingested, milk cream and other digestible fats and oils may increase absorption and so should be avoided.

Product must be watered in immediately after application to lawns. Do not apply more than 4 times per year to lawns. The minimum reapplication interval to lawns is seven days. The maximum application rate for kill of ticks is 1.15 lbs product per 1000 sq. ft.

In New York State, the product may NOT be applied to any grass or turf areas within 100 feet of a water body (lake, pond, river, stream, wetland or drainage ditch). In New York State, do make a single repeat application of this product if there are signs of renewed insect activity, but not sooner than two weeks after the first application.
